

ConnectALL End-User License Agreement

ConnectALLSM (hereafter, together with any Updates released during the Term, the "**Software**") is a proprietary software application of The Go To Group, Inc., a Maryland corporation ("**Go2Group**"). Its installation and use are subject to the terms and conditions of this End-User License Agreement (this "**EULA**"). By clicking on the "I Agree," "Agree," or similar button associated with the Software, or by using or accessing the Software irrespective of any click-through, you indicate your agreement to be bound by the terms and conditions of this EULA. If you do not agree with these terms and conditions, you should not install, use, access or permit the use of Software.

1. Defined Terms. As used in this EULA, the following capitalized terms not elsewhere defined have the following meanings:

"Affiliate" means any corporation, limited liability company or other business entity under common control with Licensee or that controls or is controlled by Licensee. For purposes of this definition, the term "control" means the power to direct the management or affairs of another, whether through the ownership of stock, by contract or otherwise.

"ALM Product" means a computer program used for the development and life-cycle management of software. By way of illustration and not limitation, ALM Products include such products as IBM DOORS, HP Quality Center, and Atlassian JIRA.

"ALM Instance" means an instance of an ALM Product.

"Authorized Device" means a computer, server or virtual (or otherwise emulated) hardware system owned or controlled by Licensee and identified by Licensee to Go2Group for purposes of this EULA.

"Authorized User" means and includes Licensee, any Affiliate and any employee of either of them.

"Embedded Third-party Software" means MuleSoft ESB and any other third-party computer program or source code incorporated in the Software under license to Go2Group.

"License" means Licensee's right to install and use the Software pursuant to this EULA.

"Licensee" or "you" means the individual or legal entity (as the case may be) licensing the Software pursuant to the Order.

"Third-party Licensor" means a licensor of Embedded Third-party Software.

"Order" means the purchase order for the Software associated with this EULA; the relevant proposal or quote submitted by Go2Group to Licensee in connection with this EULA and otherwise accepted by Licensee; or a combination of both, as the context may require.

"**Update**" means any upgrade or modified or updated version of ConnectALL made generally available by Go2Group to its customers after Effective Date.



2. INSTALLATION/HOSTING

- (a) License Type I Local Installation. If the Order specifies License Type I, Go2Group grants to Licensee a non-exclusive, non-transferable license to install one copy of the Software on one Authorized Device. Licensee may make up to three (3) copies of the Software, but only for archival, backup, and disaster recovery purposes.
- (b) License Type II Hosted Services. If the Order specifies License Type II, then in lieu of local installation Go2Group during the Term will host the Software for Licensee in accordance with Paragraph 8 and prevailing industry standards of availability, connectivity and security (collectively, the "Hosted Services").
- 3. USE. Go2Group grants to Authorized Users a non-exclusive, non-transferable license to access and use the Software during the Term to connect the ALM Instances identified in the Order (the "Designated ALM Instances"). As used in this EULA, the term "connect" means the bi-directional utilization of the Software to synchronize data shared across disparate ALM Products such that all users see the same data regardless of the product they use. The Software may not be used under this EULA to connect applications or instances other than the Designated ALM Instances. If Licensee wishes to use the Software to connect other applications or instances, Licensee must license the Software for such purposes pursuant to a separate end-user license agreement with Go2Group.
- **4. TERM.** The term of the License (the "**Term**") is one year commencing on the date Go2Group generates a license key for the Software pursuant to this EULA (the "**Effective Date**"). If Licensee wishes to continue to use the Software after the Term expires, Licensee must re-license the Software for an additional one-year term in accordance with Go2Group's then current pricing and EULA terms and conditions. If the Order specifies License Type I, Licensee acknowledges that its copy of the Software contains license protection mechanisms that will render the Software inoperative automatically when the Term expires.
- **5. FEES.** Licensee shall pay to Go2Group in advance the following fees in the specific amounts set forth in the Order. A license key for the Software will not be generated unless and until Go2Group has received full payment in United States Dollars of all applicable fees.
 - (a) In consideration of the License, Licensee shall pay to Go2Group a license fee equal to (i) the base annual subscription fee for the Software <u>plus</u> (ii) the aggregate connection fee for the Designated ALM Instances, all as more particularly set forth in the Order. Except as otherwise provided in clause (iii) of Subsection 13(b), all license fees paid to Go2Group pursuant to this EULA shall be non-refundable.
 - (b) If the Order specifies License Type II, Licensee shall pay to Go2Group in addition a separate hosting fee in consideration of the Hosted Services.
- **6. UPDATES**. If the Order specifies License Type I, Go2Group will make available to Licensee via electronic download any Updates released during the Term. If the Order specifies License Type II, Updates will be incorporated in the Software automatically.
- **7. SUPPORT.** During the Term, Go2Group will use its best efforts to provide online technical support for the Software through the ticketing system at www.jira.go2group.com or other designated support URL.



- **8. HOSTING TERMS**. The following provisions apply if the Order specifies License Type II.
 - (a) The Hosted Services are limited to providing access to the Software via the Internet on a secure application server (dedicated or virtual) controlled by Go2Group. The Hosted Services do not include data transfer services or data storage. Licensee is solely responsible for the security and integrity of its data. Go2Group is not responsible for any Licensee data lost, corrupted, altered or intercepted in connection with or as a result of Licensee's use of the Hosted Services.
 - (b) The Software will be accessible twenty-four (24) hours a day, seven (7) days a week, except for downtimes due to scheduled maintenance and required repairs or bug-fixes, and except for any loss or interruption of Hosted Services due to causes beyond the control of or not reasonably foreseeable by Go2Group, including but not limited to interruption or failure of telecommunication networks and digital transmission links, Internet slow-downs and failures, and failures of servers or other computer hardware or equipment that is not, by its nature, faulttolerant.
 - (c) Licensee is responsible for its own Internet connectivity. Licensee must use software, systems and equipment compatible with the Hosted Services, and correct ports opened for communications as Go2Group specifies in its published policies and other documentation. Any Licensee web browsers and other software must support the Secure Socket Layer (SSL) protocol or other protocols accepted by Go2Group or listed in Go2Group's documentation.
 - (d) Go2Group may use aggregate information to measure general Hosted Service usage patterns and characteristics of its user base and otherwise to improve its products and services, and may include such aggregate information about its audience in promotional materials or reports to third parties. This aggregate information will not reference names, phone numbers, email addresses, or other personally identifiable information, and it will be not traceable to a specific recipient or user email address.

9. THIRD PARY TERMS.

- (a) Terms and conditions governing the use of Embedded Third-party Software are incorporated by reference as if set forth in full.
- (b) Embedded Third-party Software includes MuleSoft ESB Community Edition ("MuleSoft ESB"). Without limiting the generality of subparagraph (a) of this paragraph, the use of MuleSoft ESB is subject to Common Public Attribution License Version 1.0 (the "MuleSoft CPAL License"), the terms and conditions of which are incorporated by reference. A copy of the MuleSoft CPAL License may be obtained at http://www.MuleSoft.com/CPAL/. The MuleSoft CPAL License is based on the Mozilla Public License Version 1.1; however, Sections 14 and 15 have been added to cover use of software over a computer network and provide for limited attribution for the Original Developer, as defined in such license. In addition, Exhibit A has been modified to be consistent with Exhibit B.
- 10. RESTRICTIONS. Licensee shall not (i) adapt, alter, create derivative works based on, modify, or translate the Software, in whole or in part; (ii) sell, assign, lease, market, rent, sublicense, or otherwise grant rights to the Software, in whole or in part, to any third party in any form; (iii) make or distribute copies of the Software except as otherwise expressly permitted hereby; (iv) obscure, remove or alter any of the trademarks, trade names, logos, patent or copyright notices or markings



incorporate in the Software or its labeling or packaging; (v) add any other notices or markings to the Software or its labeling or packaging; or (vi) reverse engineer, decompile or disassemble any component of the Software or otherwise obtain or attempt to obtain or derive the source code of the Software. The License granted hereby does not include the right to sublicense the Software to others.

- 11. DISCLAIMER. THE SOFTWARE IS PROVIDED "AS IS" AND "AS AVAILABLE" WITHOUT WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OF PERFORMANCE, MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, ALL OF WHICH ARE HEREBY DISCLAIMED. THE SOFTWARE IS PROVIDED WITH ALL FAULTS, AND THE ENTIRE RISK AS TO SATISFACTORY QUALITY, PERFORMANCE, ACCURACY, AND EFFORT IS WITH LICENSEE. THERE IS NO WARRANTY AGAINST INTERFERENCE WITH LICENSEE'S USE OR ENJOYMENT OF THE SOFTWARE OR AGAINST INFRINGEMENT.
- **12. INTELLECTUAL PROPERTY.** Licensee acknowledges that the Software and all Intellectual Property Rights associated therewith are and shall remain the exclusive property of Go2Group and its third-party licensors. All rights in and to the Software not granted to Licensee under this EULA are hereby reserved.

13. INFRINGEMENT

- (a) Go2Group will defend or settle, at its expense, any action brought against Licensee based upon the claim that the Software, if used within the scope of the License granted under this EULA, directly infringe a registered United States, European Union or Commonwealth patent or copyright; provided, however, that: (i) Licensee shall notify Go2Group promptly in writing of any such claim; (ii) Licensee shall not enter into any settlement or compromise any claim without Go2Group's prior written consent; (iii) Go2Group shall have sole control of any such action and settlement negotiations; and (iv) Licensee shall provide Go2Group with information and assistance, at Go2Group's request and expense, necessary to settle or defend such claim. Go2Group agrees to pay all damages and costs finally awarded against Licensee attributable to such claim. The foregoing states the sole liability of Go2Group and the exclusive remedy of Licensee for any infringement of intellectual property rights by the Software or any other items provided by Go2Group hereunder.
- (b) If the Software becomes, or in the opinion of Go2Group may become, the subject of a claim of infringement of any third party right, Go2Group may, at its option and in its discretion: (i) procure for Licensee the right to use the Software free of any liability; (ii) replace or modify the Software to make it non-infringing; or (iii) refund the License Fee.
- (c) Licensee will defend or settle, at its expense, any action brought against Go2Group based upon the claim that any modifications to the Software by Licensee or combination or use by Licensee of the Software with other products infringes or violates any third party right; provided, however, that: (i) Go2Group shall notify Licensee promptly in writing of any such claim; (ii) Go2Group shall not enter into any settlement or compromise any such claim without Licensee's prior written consent; (iii) Licensee shall have sole control of any such action and settlement negotiations; and (iv) Go2Group shall provide Licensee with information and assistance, at Licensee's request and expense, necessary to settle or defend such claim. Licensee agrees to pay all damages and costs finally awarded against Go2Group attributable to such claim. Go2Group's remedies under this subsection are in addition to and



- not in lieu of other available remedies for unauthorized modification of the Software or any other breach by Licensee of Section 10 of this EULA.
- (d) Notwithstanding subparagraph (a) of this paragraph, Go2Group assumes no liability hereunder for, and shall have no obligation to defend Licensee or to pay costs, damages or attorney's fees in connection with, any claim based upon Licensee's use of the Software in combination with third-party software not approved by Go2Group.

14. PUBLICITY

- (a) Go2Group may identify Licensee as a customer in Software promotional material unless and until Licensee elects to opt out of such identification pursuant to subparagraph (b) of this paragraph.
- (b) Licensee at any time may direct Go2Group to exclude Licensee from Software promotional material by submitting a written request for exclusion via email to sales@Go2Group.com. Go2Group will remove any reference to Licensee from promotional material within 30 days following its receipt of any such request.
- **15. TAXES AND DUTIES.** The fees hereunder do not include, and Licensee shall be solely responsible for, sales and use taxes and any other taxes and duties if applicable in respect of the License. If Go2Group is or becomes obligated to collect any tax or duty for which Licensee are responsible, Licensee shall pay to Go2Group the amount of such tax or duty in addition to the underlying fee.
- **16. TERMINATION.** Go2Group may cancel this EULA and terminate the License upon written or electronic notice to Licensee if Licensee breaches a material provision of this EULA. A notice of termination under this paragraph shall specify the nature of the breach and the effective termination date. If the Order specifies License Type I, then upon termination of the License pursuant to this paragraph Licensee will delete the Software from its system and destroy any archival, backup or recovery copies of the Software.

17. ASSIGNMENT

- (a) Licensee may not assign this EULA without the prior written consent of Go2Group, which consent may be withheld or conditioned in the sole and absolute discretion of Go2Group. For purposes of this paragraph, any merger or consolidation of Licensee with or into another legal entity or any sale, transfer or issuance of voting securities of or by Licensee that results in a change in control of Licensee shall constitute an assignment of this EULA by Licensee. Notwithstanding the foregoing, in the event of any such merger, consolidation, or change of control, or in the event of a sale of all or substantially all of the assets of Licensee, Licensee may assign this EULA to the successor or purchaser, as the case may be, provided Licensee notifies Go2Group in writing of the transaction not less than ninety (90) days prior to the closing thereof and provided, further, that the assignee consents and agrees in writing to be bound by this EULA as a substitute licensee.
- (b) Go2Group may assign this EULA at any time upon reasonable prior written notice to Licensee.
- **18. LIMITATION OF LIABILITY.** NEITHER PARTY (THE "BREACHING PARTY") SHALL HAVE ANY LIABILITY TO THE OTHER PARTY (THE "INJURED PARTY") FOR (I) ANY LOSS OF USE, INTERRUPTION OF BUSINESS, OR ANY INDIRECT, SPECIAL, INCIDENTAL, PUNITIVE OR CONSEQUENTIAL DAMAGES OF



ANY KIND (INCLUDING LOST PROFITS) ARISING OUT OF ANY BREACH OR NONPERFORMANCE OF THIS EULA BY THE BREACHING PARTY, REGARDLESS OF THE FORM OF ACTION, WHETHER IN CONTRACT, TORT (INCLUDING NEGLIGENCE), STRICT SOFTWARE LIABILITY OR OTHERWISE, EVEN IF THE INJURED PARTY HAS ADVISED THE BREACHING PARTY OF THE POSSIBILITY OF SUCH DAMAGES OR (II) COSTS OR DAMAGES RESULTING IN WHOLE OR IN PART FROM A CAUSE NOT WITHIN THE REASONABLE CONTROL OF THE BREACHING PARTY, INCLUDING WITHOUT LIMITATION ANY INTERRUPTION OF INTERNET CONNECTIVITY OR FAILURE OF A SERVER OR OTHER COMPUTER HARDWARE OR EQUIPMENT THAT, BY ITS NATURE, IS NOT FAULT TOLERANT. EXCEPT FOR GO2GROUP'S INDEMNIFICATION OBLIGATIONS UNDER PARAGRAPH 13, THE MAXIMUM LIABILITY OF GO2GROUP FOR CLAIMS ARISING OUT OF THIS AGREEMENT OR LICENSEE'S INSTALLATION OR USE OF THE SOFTWARE (INCLUDING CLAIMS ARISING FROM ANY CRASH, INTERRUPTION OR FAILURE OF THE SOFTWARE) SHALL NOT EXCEED THE AGGREGATE AMOUNT OF ALL FEES ACTUALLY PAID BY LICENSEE TO GO2GROUP PURUSANT TO THIS EULA.

- 19. ENTIRE AGREEMENT. This EULA constitutes the entire agreement between the parties with respect to the subject matter hereof. All prior agreements or discussions between the parties relating to such subject matter, whether written or oral, are hereby terminated and/or superseded by this EULA. Licensee acknowledges that Go2Group has made no warranties, representations, covenants or agreements with respect to the Software other than those expressly set forth herein.
- **20. AMENDMENT**. This EULA may not be modified or amended except pursuant to a written instrument signed by both parties. No course of conduct or dealing between the parties and no custom or trade usage shall be relied upon to vary the terms of this EULA.
- 21. LIABILITY OF AFFILIATES. To the extent an Affiliate elects to use the Software, the obligations of Licensee under this EULA shall be binding upon such Affiliate by virtue and as a condition of such use. Licensee shall indemnify, defend and hold harmless Go2Group from and against any and all loss, cost, liability or expense (including but not limited to reasonable attorneys' fees and court costs) arising out of or resulting from any breach of such obligations by an Affiliate.
- 22. MISCELLANEOUS. This EULA shall be deemed to have been made in the State of Maryland and shall be construed and enforced in accordance with, and the validity and performance hereof shall be governed by, the laws of the State of Maryland and the federal laws of the United States of America. The provisions of this EULA shall be deemed severable such that, if any provision or distinguishable portion of any provision is determined by a court of competent jurisdiction to be invalid or unenforceable, such invalidity or unenforceability will not affect the validity and enforceability of the other provisions. Any failure of a party to insist on or enforce strict performance of any provision of this EULA will not be construed as a waiver of such provision or right.
